NOTIFICATION

Whereas, the draft of the Karnataka Grama Swaraj and Panchayath Raj (motion of no-confidence against Adhyaksha and Upadhyaksha of Grama Panchayath) Rules, 2020 draft was published in the Part-IV-A of Karnataka Gazette dated 01.10.2020 as conferred by section 311 of the Karnataka Grama Swaraj and Panchayath Raj Act, 1993 (Karnataka Act 14 of 1993) inviting objections and suggestions to the said draft from persons likely to be affected there to within 30 days of its publication in Karnataka Gazette .

And, whereas, the said Gazette was made available to the public on 01.10.2020;

And, whereas, no objections or suggestions have been received by the state government in respect of the said draft;

Now, therefore, in exercise of the powers conferred by section 311 of the Karnataka Grama Swaraj and Panchayath Raj Act, 1993 (Karnataka Act 14 of 1993) the Government of Karnataka hereby makes the rules, namely:-

Rules

1. **Title and commencement:-** 1) These rules shall be called the Karnataka Grama Swaraj and Panchayath Raj (Motion of No-confidence Against Adhyaksha and Upadhyaksha of Grama Panchayath (Amendment) Rules, 2020.
2) They shall come in to force from the date of final Publication in Official Gazette
2. **Amendment of rule 3:-** In the section 3 of the Karnataka Grama Swaraj and Panchayath Raj (Motion of No-confidence Against Adhyaksha and Upadhyaksha of Grama Panchayath) Rules, 1994,
 - (i) The words, numbers and brackets shall be omitted, in sub rule (1) specified under subsection (2) of section 49, written witnesses and evidences enlisted for particular allegations shall be submitted along with the written notice in person).

- (ii) In sub rule (2) namely "The Assistant Commissioners shall make sure that the enlisted allegations attached to the notice are specific by obtaining a report within seven days from the respective Taluk Panchayath Executive Officer" shall be omitted.
